The following errata refer to the version of the Land of the Crane published by Green Ronin Publishing in True20 Worlds of Adventure.

Credits

On the credit page, one author's name was left out. The full credits should read:

*David Garrett, with rules and setting material by David Garrett, David Kuchler, Scott Perry, Robert J. Schumacher, **Philippe Tourigny**, and Sarah Zielinski*

Content

p55 – in the upper right-hand corner of the map, the mountain range should be labeled “**Hizuru Range**,” not “**Hiruzu Range**.”

p59 – the description of the Jade Fist ninja guild refers to the “Kiriko-shū and Senryu-shū” guilds. The “Senryu-shū” guild does not appear in this version of the material.

p65 – the starting feats for a Darumist Monk include “Mind over Body.” Replace this with “Evasion.”

p75 – the Difficulty for summoning a spirit should be **15** plus the intended level of the spirit,



instead of **10** plus the intended level of the spirit, as stated.

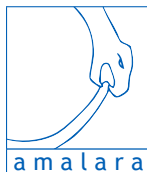


